## **Specifications for Bridge Timbers**

For Bridge Timber Specifications please refer to AREMA Chapter 7 Timber Structures. Specifically to Table 7-2-9 "Allowable Stresses for Stress Graded Lumber -Railroad Loading (Visual Grading)". For example: . . . . hardwood species, the table will refer you to "Beams & Stringers" in the Northeastern Lumber Manufacturers Association (NELMA) grading rules. To arrive at the correct grade for their application users need a clear understanding of the design loads and allowable working stresses for the structure and any environmental conditions which would require the use of stress reduction factors. Chapter 7 was written by Structure Design Engineers for structural engineers.
